



# ERICEIRAYOGASTUDIO

## Registration Conditions . 2024

### PACKS

- \* The packs of 5 and 10 classes are for personal use only, not refundable, are valid for 3 and 6 months, respectively.
- \* The 30-day pass includes one class per day, and does not include Aerial Yoga. Compensation beyond the pass end date is not permitted.

### MONTHLY / QUARTERLY FEES

- \* The monthly / quarterly payment is made until the 8th of the month, involves an inscription fee and do not include aerial yoga classes. If you keep your regular attendance you will not have to pay it again in the following year, the studio will offer you the annual re-enrollment, but if you interrupt the monthly / quarterly payment in a period exceeding 1 month of vacation, or temporarily want to interrupt the monthly payment and join to a pack of classes, you will have to pay a new inscription fee if you want to return to the monthly / quarterly regime.
- \* The monthly / quarterly payment is made regardless of the actual use of the classes or other possible changes in circumstances. There are no refunds. The student is entitled to an exemption from payment only during 1 vacation month, or 4 weeks, or in the case of pregnancy, postpartum period, attested illness by medical declaration. That is, the student will pay 11 months per year.
- \* Half-month or adjustment to monthly payments are not accepted, except in the 1st month of practice.
- \* If you join a 3-month-quarterly plan, and the student takes a vacation, or the Studio closes for reasons of force majeure, the student will have a credit for that time to enjoy at the end of plan of payment.
- \* The practitioner will be able to make up for missed classes until the last day of the month to which the absences relate.
- \* Students up to 23 years old have a 20% discount if they attend 2 or more classes per week and on the inscription fee. They are exempt from paying the months of July and August if they do not come to classes, and can only pay half a month in September, December, and April if they only want to attend classes in the two weeks that coincide with their school calendar.

### GENERAL CONDITIONS

- \* If you need a receipt with nif, you must request to your teacher it before the end of the month.
- \* Ericeira Yoga Studio, as well as the respective teachers, are not responsible for the physical and / or psychological damages that may occur during classes, being the student's responsibility to inform the teacher of any physical or other limitations of which they are subject, and pregnancy.
- \* All registered students (with monthly fees, quarterly fees and packages) sign the following on the registration form, as well as drop-in students on the term of responsibility:  
*I declare, on my honor, that I do not have any contraindications for the practice of the physical activity I propose to do - Yoga, under the terms of Article 40, of Law 5/2007 of January 16, and that I accept the conditions of this registration, being aware of all the rules of operation of this Yoga Studio.*
